Identity of the Data Controller	You have provided, are about to provide or will provide personal data to Union des Association Européennes de Football and UEFA Events SA (collectively "UEFA") , whose offices are located at Route de Genève 46, 1260 Nyon 2, Switzerland, acting as data controller, on its uefa.com platform in accordance with the uefa.com Terms and Conditions (the "Terms and Conditions").
Which personal data is collected?	The following personal data about you will be processed by UEFA: identity data, contact data, profile data and marketing and communications data.
How are these data processed and why?	<p>Your personal data are collected and processed for the purposes of processing your pre-registration on the UEFA Women's EURO 2022™ ticketing portal ("the Portal") and for providing you with access to a dedicated internet platform, through which you will get priority ticket access and be the first to know about ticket for UEFA Womens' EURO 2022™.</p> <p>Your personal data are processed by UEFA on the basis that such processing is necessary for the performance of the Terms and Conditions entered into between you and UEFA, and/or for the purposes of legitimate interest to communicate with you relating to ticketing sales and tournament information.</p>
Who are the recipients of the personal data?	<p>You understand that the personal data will be processed within UEFA and its subsidiary UEFA Events SA (UEFA's service provider in relation to the ticketing process), by their employees and any third party appointed by them to assist in the ticketing process.</p> <p>In particular, you acknowledge that the personal data you are submitting will be available to and processed by the Football Association (the Host Association), including its subsidiaries and any third party appointed by the Football Association, who will assist in the promotion of the UEFA Women's EURO 2022™, including send newsletters to fans who have registered on the Portal.</p> <p>UEFA may grant access to certain personal data to third party technical service providers which help to maintain the security and performance of the uefa.com platform and any other internet platform.</p>

<p>How to assert your rights?</p>	<p>You can access, update and delete your personal data directly in your personal account on the Portal.</p> <p>If you have any question about your personal data, please contact us at: https://support.tickets-weuro.uefa.com/hc/en-us/requests/new</p> <p>You have also the right to lodge a complaint with your local Data Protection Supervisory Authority and have the ability to seek to enforce your rights through a judicial remedy.</p>
<p>Where and how long are your personal data stored?</p>	<p>All personal data provided to UEFA shall be stored in the Platform in a database located in Switzerland and/or within the European Union.</p> <p>Your personal data is only collected and processed by UEFA for no longer than is necessary for the purposes described above, unless the use of such personal data is further required for ongoing administrative or judicial proceedings relating to the relevant match or, where necessary, for preventing or detecting unlawful actions.</p>
