	Your personal data are processed by UEFA on the basis that such processing is necessary for the performance of the Terms and Conditions entered into between you and UEFA, and/or for the purposes of legitimate interest to communicate with you relating to ticketing sales and tournament information.
Who are the recipients of the personal data?	You understand that the personal data will be processed within UEFA and its subsidiary UEFA Events SA (UEFA's service provider in relation to the ticketing process), by their employees and any third party appointed by them to assist in the ticketing process.
	In particular, you acknowledge that the personal data you are submitting will be available to and processed by the Football Association (the Host Association), including its subsidiaries and any third party appointed by the Football Association, who will assist in the promotion of the UEFA Women's EURO 2022™, including send newsletters to fans who have registered on the Portal.
	UEFA may grant access to certain personal data to third party technical service providers which help to maintain the security and performance of the uefa.com platform and any other internet platform.

Where and how long are your personal data stored?	All personal data provided to UEFA shall be stored in the Platform in a database located in Switzerland and/or within the European Union. Your personal data is only collected and processed by UEFA for no longer than is necessary for the purposes described above, unless the use of such personal data is further required for ongoing administrative or judicial proceedings relating to the relevant match or, where necessary, for preventing or detecting unlawful actions.
